TERMS AND CONDITIONS

1. The provision of the frozen equine semen under this contract ("the Semen") is conditional upon the receipt by International Horse Breeders Pty Limited ("IHB") of a signed Veterinarian's Agreement, in a form approved by IHB, from the veterinarian ("the Veterinarian") that you wish to engage to perform the actual inseminations. Veterinarian surgeons must be ones recommended by IHB.
2. You must advise IHB of any other veterinarian that you wish to engage in addition to or in substitution for the Veterinarian and IHB must receive a signed Veterinarian's Agreement, in a form approved by IHB, from any such veterinarian, before that veterinarian performs any inseminations using the Semen.
3. The Semen is provided for the purpose of achieving one successful pregnancy, through insemination in the mare, notified to us in writing or verbally by you.
4. If you have achieved a successful pregnancy, using the Semen, and you wish to retain and use any remaining Semen for the purpose of attempting an additional pregnancy, or pregnancies, you must first enter into a further contract with IHB pursuant to which you will be required to pay for an additional service fee(s).
5. If you have achieved a successful pregnancy, using the Semen, and you do not wish to retain and use any of the remaining Semen for the purpose of attempting additional pregnancies as per clause 4, you must arrange to have the remaining Semen returned to IHB.
6. IHB will provide Service Certificates for births that have been the result of the use of the Semen but only where the Semen has been used in accordance with these Terms and Conditions.
7. No Embryo Transfers are permitted. A vet recommended by IHB must be used.
8. Mares entering into a frozen AI program must be aged between 3 and 16 years of age with a good breeding history. She must be deemed fit for breeding by the vet concerned. If a mare is vet checked and deemed unfit by the vet another mare may be substituted.
9. If mare fails to get in foal with initial 3 inseminations of semen a refund for the cost of the semen will be given.
10. All pregnant mares must be pregnancy tested at 45 days. Mare owners must provide veterinary certification as proof of mare being empty at 45 days.
11. Client agrees to permit IHB to obtain information concerning AI program from vet.
12. If mare fails to get in foal for whatever reason the mare owner will hold stallion owner and IHB blameless.
